The actual fee will depend on the complexity of your situation and the time it takes to prepare personal financial advice for you.</p> <p>I may charge a placement fee and/or implementation fee to implement the recommendations in your financial plan. These are payable when you decide to proceed with the implementation of any one or more recommendations that I provide to you. The actual fee will depend on the complexity of your situation and the amount of funds invested, but will not exceed:</p> <ul style="list-style-type: none">• a range from \$3,000 (min.) to \$30,000 (max.); or• \$360 per hour; or• 66% of premium; or• the maximum of entry fees or contribution fees specified in the Product Disclosure Statement (PDS) for the recommended product; <p>whichever is the greater.</p>
Ongoing advice	<p>Key Choice Financial Solutions offers our clients an ongoing advisory service. The ongoing advice fee will be based on the level of service required, the frequency of the review and the complexity of the advice. Complex advice requirements include the use of trusts and other legal ownership structures, overseas assets or income, executive options or multiple investment entities. If you choose to have me provide an ongoing advice service, you may be charged a fee ranging from \$3,500 to \$30,000.</p>
Ad hoc advice	<p>The fees for the provision of ad hoc advice not covered by an Ongoing Service arrangement will be charged on an hourly basis at a rate of \$360.</p>
Insurance products	<p>We will receive commission for our initial and ongoing services to you.</p> <p>Initial commission is between 0% and 66% and the ongoing commission is between 0% and 30% of the annual premium and is paid by the insurance product issuer to us.</p>

If applicable, all fees will be clearly disclosed to you in writing, following an assessment of the work required. No fees will be charged without your prior consent, and you will be informed prior to the commencement of any work.
Stamping fees	Where we receive stamping fees from issuer companies for raising capital or debt on behalf of that company, we will offset this payment against the cost of our advice to you.
